Check the citizenship status that applies to you and submit one (1) of the required documents:

- U.S. Citizen or Naturalized U.S. Citizen
  - ❖ Birth certificate if you were born in the U.S.
  - ❖ Certification of Naturalization (N-550 or N-570)
  - ❖ Certificate of Citizenship (N560 or N561)
  - ❖ State Department Form (FS-240, 545, DS 1350)
  - ❖ U.S. Passport (current or expired)
  
- Permanent Resident of the U.S.
  - ❖ Resident Alien Card (I-551 issued before 1997) both sides required
  - ❖ Permanent Resident Card (I-551 issued after 1997)
  - ❖ Alien Registration Receipt Card (I-151 issued before June 1978)
  - ❖ Arrival/Departure Record (form I-94) stamped "Processed for I-551" or "Temporary Form I-551"
  
- Eligible Non-citizen
  - ❖ Arrival/Departure Record (form I-94) stamped or endorsed as one of the following:
    - "Admitted as a Refugee Pursuant to Section 207 of the Act. If you depart the U.S. you will need prior permission to return. Employment Authorized" -or- "Status changed to refugee pursuant to Section 207 (c)(2) of the Immigration Nationality Act, on \_\_\_\_\_. Employment Authorized."
    - "Asylum status granted pursuant to Section 208, USCIS. Valid to \_\_\_\_\_. Employment Authorized."
    - A stamp indicating that the student has been paroled into the United States for at least one year, with a date that has not expired.
    - "Cuban-Haitian Entrant"
    - Victims of human trafficking with 1-94 coded as T1, T2, T3, or T COA
  - ❖ Violence Against Women Act (VAWA):
    - Provide a 1-797 form or Certification Letter establishment of prima facie case.

**Note:** Documentation provided as proof of your immigration status may legally be photocopied by the Financial Aid Office as long as the photocopy is made for this lawful purpose. Document photocopying is generally not permitted for other purposes.
