This position will work with students that are indentured as electrical apprentices with local electrical businesses in Oregon and Idaho.

The position will collaborate with other instructors in the program to develop, maintain and modify curriculum, enhance best-practices, and generate comradery among the cohorts.

The Electrical Apprenticeship part-time instructor position(s) will be responsible for apprenticeship related training courses. Provide quality and engaging instruction in all delivery methods and formats. Provide timely and meaningful feedback to students regarding the mastery of course and program learning outcomes. Demonstrate strong interpersonal, communication, technical and organizational skills. Demonstrate the ability to use technology with students in the classroom

# **ESSENTIAL FUNCTIONS:**

- Teaches assigned classes following approved course outline; prepares and develops materials for assigned classes; provides students and college with course syllabi and recommends textbooks and other instructional materials and/or equipment.
- Provides classroom environment conductive to learner growth in a variety of delivery methods.

- Maintain records of attendance, student goals and outcomes, student progress and other required student data for TVCC and the Electrical Licensing Boards.
- Use a Learning Management System (LMS) to facilitate teaching, learning assessment, and communication.

## TERMS OF EMPLOYMENT

- Apprenticeship classes are held from 6:00pm 9:00 pm in the evenings.
- Classes are held Monday, Tuesday, Wednesday and/or Thursday evening depending on which Year is being taught.
- Prep work is required to be prepared to teach weekly.
- Courses are held from August May annually.
- Part-time up to 6-8 hours per week to include prep time and office hours.
