### **TVCC Nursing Assistant Program Enrollment Agreement & Disclosure Statement**

#### **PROGRAM OVERVIEW**

This course is a 10-week course of 110 hours which is divided into 40 hours of didactic, 28 hours of lab, 40 hours clinical, and a 2 hour Final Exam. Didactic is performed in a synchronous hybrid online format. Lab skills are performed at the TVCC's Ontario Campus-Nursing Lab. Clinical experiences are performed in local long-term and acute care facilities. The clinical time will be an opportunity for students to acquire "real life" experience as a student nursing assistant. The objective is to have the knowledge to successfully pass the certification examination and have the competency to safely provide nursing assistant care. To achieve the objective, course subjects include:

- Interpersonal Skills and Communication
- Growth and Development throughout the life cycle
- Cultural Aspects
- Legal/Ethical Aspects
- Medical and Nursing Terminology
- General Patient Care
- Infection Control

#### **SCHEDULE**

TVCC's Nursing Assistant course is offered quarterly; each quarter is 10-weeks. The weekly schedule is found <https://www.tvcc.cc/nursing/na/index.cfm>. Didactic instruction is through two online platforms, TVCC's Learning Management System (LMS) Canvas and Zoom. Students are expected to have internet capable of supporting an online learning environment. Skills labs are in-person at TVCC's Ontario Campus-Nursing Lab and will be completed prior to entering the clinical environment. Clinical experiences are in-person at local long-term care and/or acute care facilities. Additional clinical sites may be added, TBD. Both skills lab and clinical experience are expected commitments and alternative schedules are not offered. Skills lab and clinical experiences are regularly scheduled on Fridays. Summer schedule will include two days of clinical experiences. Didactic synchronous hybrid online learning is regularly scheduled for three mid-week evenings from approximately 6pm-10pm; final course schedules correspond to TVCC's Academic Calendar.

#### **RESIDENCY REQUIREMENTS**

### **TUITION REFUND FOR NONCREDIT CLASSES**

A refund for noncredit classes will be considered on a case-by-case basis. Withdrawal requests must be made by email request to the Nursing Department Program Coordinator in addition to completing the TVCC official add/drop forms/web forms or complete withdrawal procedures.

### **INSTITUTIONAL CHARGES**

The student may be entitled to a refund of institutional charges if:

1. The student is dropping/withdrawing any or all classes during the first 10 days of scheduled instruction in the term for which he or she was charged, (prorated to eight days of scheduled instruction in summer quarters) and the student has notified the College of his or her total withdrawal by completing official withdrawal processes.

Institutional charges will be refunded at 100 percent during the first 10 days of scheduled instruction (eight in summer quarters), 0 percent thereafter.

2. The student is dropping/withdrawing from a late-start class that has not yet met according to the quarterly class schedule and the student has notified the College of his or her total withdrawal by completing official withdrawal processes.

Institutional charges will be refunded at 100 percent.

The application process begins with the understanding that after completing the 10-week nursing assistant course you will be prepared to take the national licensing exam to become certified through the Oregon Board of Nursing (OSBN). Upon successful completion of the approved OSBN Nursing Assistant 1 Course (110 hours), you will receive a Certificate of Completion. This certificate will enable you to take the certification test. When this exam is passed, you will be issued the designation of a "Certified Nurse Assistant".

Please follow the following steps 1-9 in order to complete your nursing assistant application:

1. Become a TVCCC student, apply for admission to Treasure Valley Community College:

2. During the TVCC application process, on the Enrollment Status page, students will need to select: "Short Term Training".
3. Once you have registered as a student with TVCC, please continue with the additional application requirements listed below.
4. Remember you will receive an acceptance letter from the college, this does not indicate acceptance to the Nursing Assistant course. After you have been enrolled in the college, contact [nursing@tvcc.cc](mailto:nursing@tvcc.cc) to continue this application and all the requirements necessary for enrollment into the NA course. Once enrolled in the NA course, follow steps 5-9
5. Register with American Databank. It is essential you use your own personal email and full legal name.

  - From this site you will select "The Nursing Assistant Package" which is the required background check and drug screen urinalysis.
  - Select a drug screen collection site location.
  - If a local drug screening facility is not easily accessible, please notify the Nursing Program Coordinator. You will be permitted to complete your urine drug screen while on campus in Ontario on the first day of lab. (\*Once you order your drug screen urinalysis you will only have 30 days till the form expires, if this form expires you will have to pay to register for another form.)
6. The following documents are required with your application:
  - Copy of current health care insurance.
  - Copy of Immunization records (plus COVID and influenza)
  - Copy of Negative Tuberculosis (TB) test (PPD, T-Spot, or QuantiFERON accepted)
  - Copy of an American Heart Association (AHA) Basic Life Support BLS/CPR card or certificate. If you do not have this or it is NOT AHA, a CPR/BLS course will be offered the first week of the Nursing Assistant course. Please contact the Nursing Program Coordinator for details.
  - Copy of High School Diploma/GED or College transcript with Writing 90 or higher completed and passed with a "C" or better, or - "Next Generation Sentence Skills" test with a score of 237 or better.

7. You must complete a health physical examination, with the form in this application, see page 6.
8. Signed Enrollment Agreement & Disclosure Statement (separate document)

REGISTRATION REQUIREMENTS

All required documentation must be received by the Nursing Program Coordinator one week prior to the start of the quarter/course. Upon entering the Nursing Assistant course, the student must be at least 16 years of age, in good health, and be current on required immunizations. The applicant must pass a background check and drug screen urinalysis. Please see the links on the application page for specifics related to background concerns. After the Nursing Program Coordinator has received the registration requirements, the student will receive TVCC Nursing Assistant Registration Form. This form must be submitted by the student to TVCC's Student Services as proof you have been accepted into the Nursing Assistant Program.

\*Please note, registration is not complete until you have submitted this document to Student Services.

SELECTION PROCESS

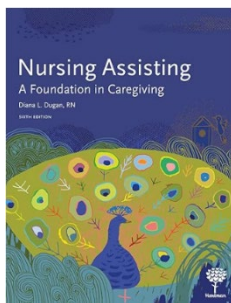

DRUG SCREENING URINALYSIS

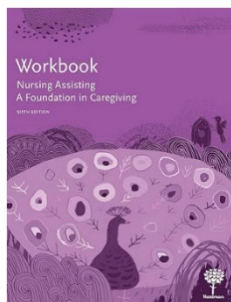
- Students must obtain a 10-panel urinalysis drug screening through American Databank prior to clinical experiences. Please be aware NO student will attend clinical without completed compliance documents.
- Students must use the location selected during the ordering process, please pay attention to the location, once selected it cannot be changed.
- Print the drug screen form and take to the selected certified lab that was selected during ordering
- Contact the selected certified lab to schedule an appointment
- Results will be automatically uploaded on student's American Databank account

## DIVISION 12 - RULES OF PRACTICE AND PROCEDURE

**OAR 851-001-0115 Criminal Background Checks**

The Board of Nursing will perform national fingerprint and state records criminal background checks on all Licensee Applicants; or Persons who are employed or who seek to be employed by the Board; or who is providing services or seeks to provide services to the Board on a contractual or volunteer basis will be referred to in this rule as an "SI" as defined in ORS 181A.190 (Criminal records check)(1)(c), OAR 125-007-0210 (Definitions)(10):

- (1) The Board of Nursing, in making fitness determinations consistent with the intent of ORS 181A and rules promulgated by the Department of Administrative Services 125-007-0200 (Statement of Purpose) to 0330 et seq. shall consider:
- (a) The nature of the crime;
  - (b) The facts that support the conviction or pending indictment or that indicate the making of a false statement;
  - (c) The relevancy, if any, of the crime or the false statement to the specific requirements of the subject individual's present or proposed position, license, certification or registration;
  - (d) Intervening circumstances relevant to the responsibilities and circumstances of the position, license, certification, or registration, such as:
    - (A) The passage of time since the commission of the crime;
    - (B) The age of the subject individual at the time of the crime;
    - (C) The likelihood of a repetition of the offenses or of the commission of the crime;
    - (D) The subsequent commission of another relevant crime;
    - (E) Whether the conviction was set aside and the legal effect of setting aside of the conviction; and
    - (F) Letters of support that would supply evidence of current character.
- (2) The Board will evaluate a conviction or pending indictment or that indicate the making of a false statement; crime or offense on the basis of law of the jurisdiction in which the crime or offense occurred.
- (3) A conviction of any of the following crimes or offenses is potentially disqualifying, unless otherwise provided by law.
- (a) All Felonies.
  - (b) All misdemeanors.
  - (c) Any U.S. military crimes or international crimes.
- (4) The Board of Nursing in and through its designee(s) shall evaluate a crime or offense on the basis of the law of the jurisdiction in which the crime or offense occurred.
- (5) The following are examples of crimes likely to result in denial unless there are significant mitigating circumstances.
- (a) Aggravated murder as in ORS 163.095 ("Aggravated murder" defined)
  - (b) Murder as in ORS 163.115 (Murder in the second degree)
  - (c) Rape 1 as in ORS 163.375 (Rape in the first degree)
  - (d) Sodomy 1 as in ORS 163.405 (Sodomy in the first degree)
  - (e) Unlawful sexual penetration as in ORS 163.411 (Unlawful sexual penetration in the first degree)
  - (f) Sexual Abuse as in ORS 163.427 (Sexual abuse in the first degree)
- (6) Under no circumstances shall a SI be denied under these rules because of a juvenile record that has been expunged or set aside pursuant to ORS 419A.260 (Expunction) to 419A.262 (Expunction proceeding).
- (7) Under no circumstances shall SI be denied under these rules due to existence of contents of an adult record that has been set aside pursuant to ORS 137.225 (Order setting aside conviction or record of criminal charge).
- (8) Examples of other criminal offender information that may be potentially disqualifying may include:
- (a) Sex offender registration;
  - (b) Conditions of parole, probation, or diversion program; or
  - (c) Unresolved arrest, charge, pending indictment or outstanding warrant.
- (9) The Board will be the determiner of the validity of all criminal background check information received.

- Return completed Health/Physical Examination Form to the Nursing Program Coordinator.
- Make an appointment with Student Disability Services *if* there are any conditions that may interfere with performance of essential duties and to determine what accommodation would be reasonable in a clinical setting.
- Save a copy of all documents for your personal files.

## TECHNICAL STANDARDS\*

## Oregon Council of Associate Degree and Practical Nursing Programs (OCAP)

Students admitted to the Nursing Assistant Course are expected to be able to complete curriculum requirements which include physical, cognitive, and behavioral core competencies that are essential to the functions of the entry level professional nurse. These core competencies are considered to be the minimum and essential skills necessary to protect the public. These abilities are encountered in unique combinations in the provision of safe and effective nursing care.

Progression in the course may be denied if a student is unable to demonstrate the technical standards with or without reasonable accommodation.

**Cognitive:**

The student must have sufficient emotional stability to perform under stress produced by both academic study and the necessity of performing nursing care in real patient situations while being observed by the instructors and other health care personnel.

**Physical:**

In order to participate in TVCC Nursing Program, students are required to travel to agencies and hospitals, and to homes with unpredictable environments. Students need to have the endurance to adapt to a physically and emotionally demanding program. The following physical requirements are necessary to participate in the clinical application courses in nursing: Strength: Sufficient strength to lift, move and transfer most patients; to restrain and carry children; to move and carry equipment; and to perform CPR, which requires sufficient bodyweight and adequate lung expansion.

*Mobility:* Sufficient to bend, stoop, get down on the floor; combination of strength, dexterity, mobility and coordination to assist patients; ability to move around physically and adequately in confined spaces (patient rooms, bathrooms, treatment settings, around patient equipment, etc.). Be able to perform all physical skills required to deliver patient care such as CPR, ambulation, transport, reposition, lifting, and other nursing duties.

*Fine Motor Movements:* Necessary to manipulate syringes and IVs; to assist patients with feeding and hygiene; to write appropriate notations; to document in health record; to perform sterile procedures and other skilled procedures.

*Speech:* Ability to speak clearly in order to communicate with staff, physicians and patients; need to be understood on the telephone.

*Vision:* Visualize patients in order to assess and observe their health status; skin tone, color changes, dermatological conditions, non-verbal behaviors, changes in signs and symptoms of illness, health improvement or deterioration, etc.

*Hearing:* Hear and see patients, monitor signs and symptoms, hear alarms, patient voices, call lights, and assess patient conditions, non-verbal behaviors, changes in signs and symptoms of illness, health improvement or deterioration, hear through the stethoscope to discriminate sounds, and accurately hear on the telephone.

*Touch:* Ability to palpate both superficially and deeply and to discriminate tactile sensations.
