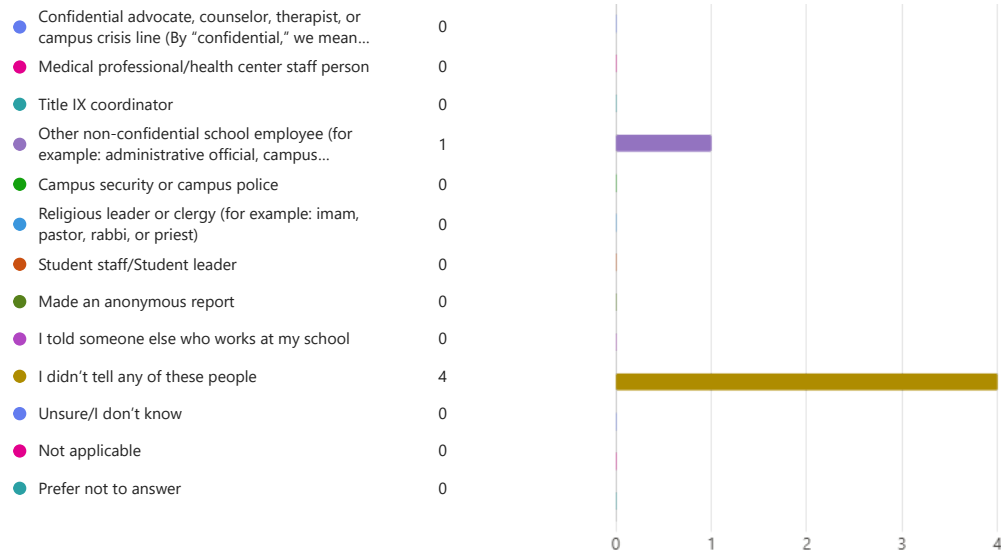
127. DRC2 Why didn't you tell anyone about what happened? Please select all that apply.

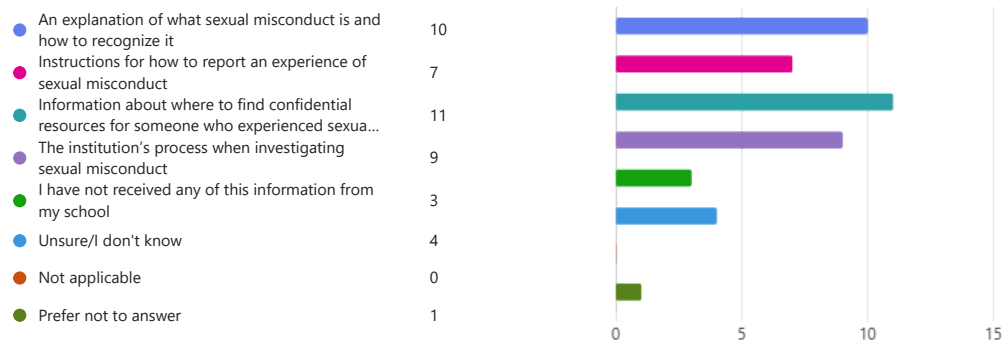
144. ASA2 I know how my institution's policy defines sexual misconduct.

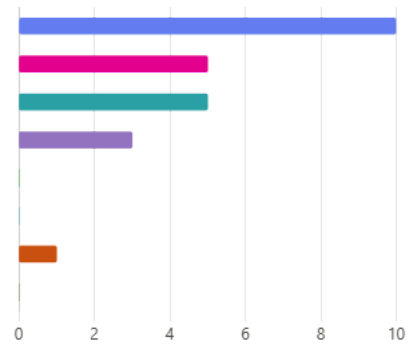
151. ASA9 I feel safe from stalking at this school.

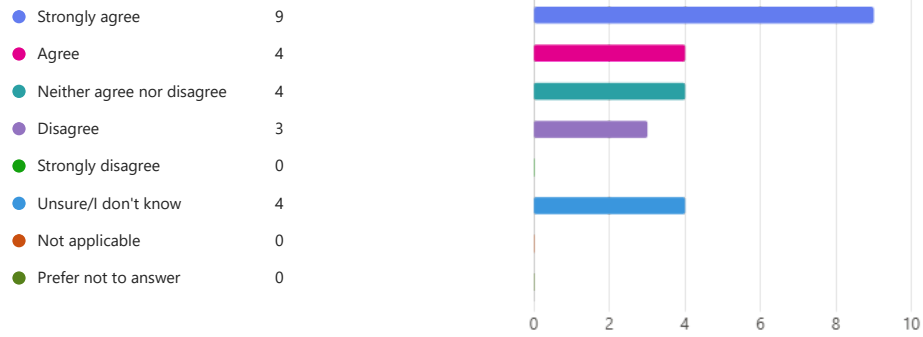


152. ASA10 This school does a good job of protecting students from sexual misconduct.

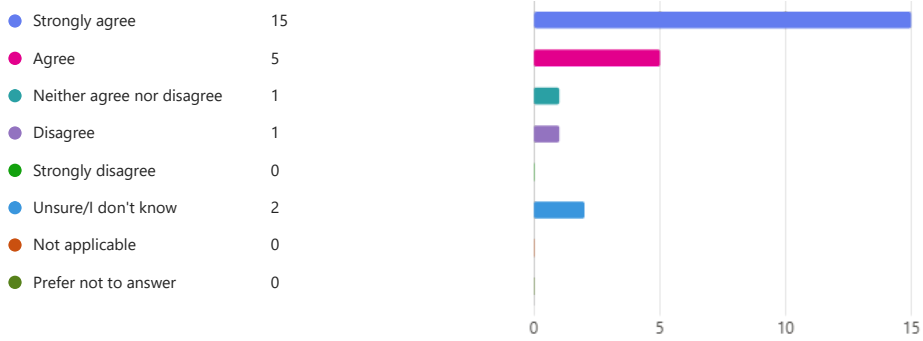

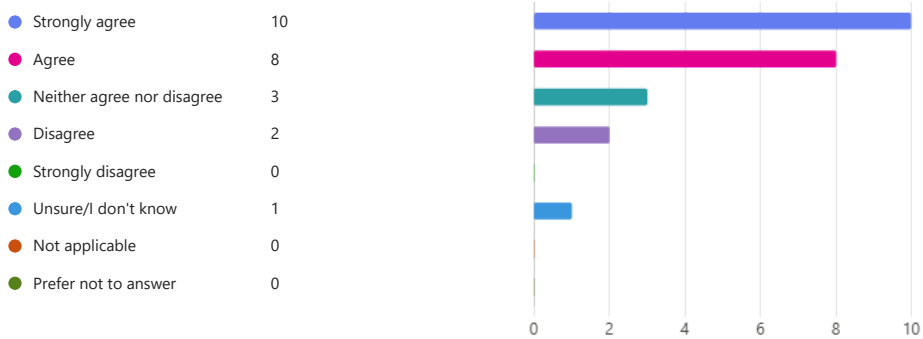
153. ASA11 The people who work at this school provide the school community with training for preventing sexual misconduct.



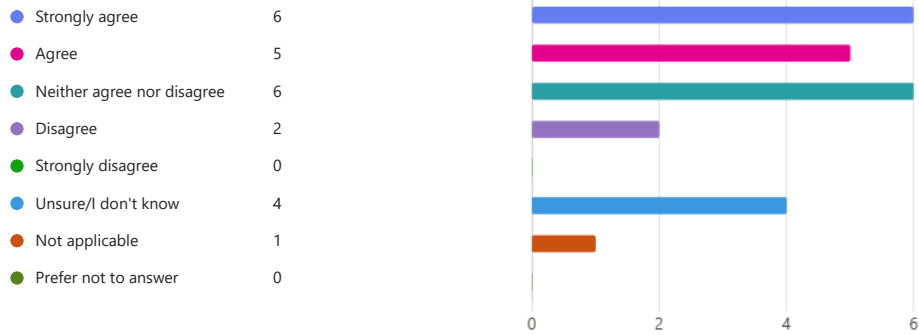
